

# Meeting Minutes 1720 Rio Drive Mission, Texas 78572 January 21, 2021

MMHOA President, L. Vasquez, called meeting to order at 8:05 am.

**Members attending**: L. Vasquez, D. King, J. Vasquez, A. Tunseth, B. Salinas and N. Ewasko. D. Solis was absent. T. Retka and B. Bloczynski were also present.

#### 2. Minutes:

## 3. Treasurer's Report:

### 4. Annual Dues Reminder Notes

### 5. Old Business:

\* Lights Around the Pool: D. King announced that he has received positive feedback from the community. The cost of the lights is less than \$200.00. L. Vasquez motioned to approve the expenditure for the lights. Everybody approved the motion. Motion carried.

- \* Spa. Leak: D. King informed two options to fix the leak:
- 1.) \$695.00 leak test plus an estimate leak repair of, approximate to \$2000.00. Or
- 2.) Eliminate leaking spa jet system by capping off 6 jets and converting circulation system to jet nozzles, approximate cost \$50.00. All members approved the second option.
- \* Bathroom lights: Two options were discussed:
- 1.) Replace 8 fluorescent fixtures with LED lights for about \$200.00. Or
- 2). N. Ewasko suggested "disinfectant lighting" which she will explain about them next meeting.
- \* <u>Disposal of the pool cover:</u> D. King offered to haul away the cover and the lights. T. Retka and L. Vasquez offered to help.
- \* Review the 2020 MM Annual Meeting Minutes: All members read the minutes. The spelling of the word arrangements was pointed out. B. Salinas will make the correction and print out 40 copies for the MM Annual Meeting on Feb. 6, 2021.
- \*New 2021-22 MM Board of Directors: There is a need of 4 new members for the board.

  - 4. Member-at-Large

Possible candidates: N. Ewasko informed that she will continue to help. B. Bloczynski, who attended the meeting, is willing to participate. T. Retka informed that P. Bond is interested in helping and possibly C. Cook. D. King said that M. Anil is also interested in participating on the board.
