- <u>SPA Leak</u>: D. King explained that the work was more complicated than expected, but it has been completed. The total cost was \$3,000.00
- Pending Occupancy Forms: All forms have been collected.
- <u>MM Telephone Directory.</u> D. Solis will update it and provide a hard copy to B. Salinas. This issue is still pending.
- <u>Bathrooms/ Showers Roof Repair bids</u>: There were 3 roof repairs bids. Estimates and pictures taken by all three companies were compared. All pictures were similar. One company asked for \$650.00, another asked for \$600.00 and the third one asked for \$425.00. Unfortunately, the person whose bid was for \$425.00 did not show up. A. Malhotra will contact the person whose bid is \$600.00. Hopefully, the repairs will be done by next meeting.
- <u>Champion Electric rate approval</u>: P. Bond contacted the Champion Electric Company. She reported that the rate went down one cent.
- <u>1601 E. replacement trellis small backyard patio roof</u>: This issue is still pending.

- Grubs: A. Malhotra will contact Pancho to treat the affected area.
- <u>MMHOA Insurance:</u> A. Malhotra completed and submitted the application. He is waiting for a response.

5. Other Business:

- Weeding around the pond: P. Bond will call Jose, who has done this work in the past, to see if he is still doing this kind of work.
- Solar panels 1708 lowa: D. King explained that he did not received an architectural form for this addition- improvement to the house. The board members discussed the fact that there are too many additions improvements to the properties and we need to find a way to let the new house buyers about the association regulations. This issue is still pending.
- <u>Pool Pump situation</u> <u>Variable speed pump:</u> D. King explained that there are
 4 of this kind of pumps. They are still in good working condition, but he
 recommended to buy a standby pump since the other one was used. He
 informed that these pumps are being fazed out and the board should
 consider purchasing extras instead of the mandatory more expensive
 variable speed type. A. Malhotra will research this issue and it will be
 discussed on the July 15 meeting.
