One delinquent payment has been returned as insufficient. Bank fees will be added to the balance due.

A check was received for delinquent special assessment in the amount of \$210.00. President Alvarez made a motion to waive the delinquent fees for this property only. Director Bond seconded the motion. Motion carried.
